We take your privacy seriously, whether you are a member, a visitor to our website, opted in to receive our emails or have been invited to attend one of our events. #### 1. WHAT INFORMATION WE COLLECT

- 1.1 When you use our website or sign up for our newsletter, we collect information about you, including your personal information. "Personal Information" is information that identifies you and can be used to locate and contact you.
- 1.2 We may collect Personal Information including your name, address, phone number, email address and other information that you voluntarily provide to us for the purposes of communicating. When you sign up to receive our newsletter or request to be added to mailing list, we may collect "Personal Information" including name, email, organization, address, postal code.
- 1.3 We may also obtain information about you from third-party websites or public sources. If you connect with us on social media (X/Twitter, Facebook, LinkedIn, Instagram, and/or YouTube), we may use the data analytics and advertising tools to obtain information such as demographics, interests, and locations for research and advertising purposes.

#### 2. WEBSITE NAVIGATION

- 2.1 Cookies: We many collect some information from you using "cookies." A "Cookie" is a small bit of information stored on your computer based on your internet activity. Cookies help us track and understand how you interact with our site. For more information on your option regarding Cookies, see Section 6.2.
- 2.2 **Google Analytics:** We use Google Analytics to measure traffic on the businesscouncilab.com website. Google Analytics uses tools like cookies and Javascript to anonymously collect information about your interactions with our site. This information may include which pages you visit, for how long and how you found our site. We use this information to update and

administer our website, determine how you are using the website and make the necessary improvements to deliver the best user experience possible.

- 2.3 **Cross-Device Tracking:** BCA may use cross-device tracking tools such as the Facebook Pixel, and others, to gather information about an individual's activity and behaviour across devices.
- 2.4 **Social Media Plug-Ins and Website Links:** We may use social media plug-ins and include links to other websites on our site to enable you to share our content and information with others. These plug-ins might include those from companies such as Facebook, Twitter, LinkedIn, Instagram and/or YouTube. These plug-ins may allow these companies to access identifiable Personal Information about you and your visit to our website. We do not control how these companies use the information collected by these plug-ins. For more information on how this information will be used, visit these companies' privacy and data sharing statements.

#### 3. HOW WE USE YOUR INFORMATION

- 3.1 We may use your Personal Information and non-personally identifiable information in the following ways:
  - To administer the businessacouncilab.com website
  - To respond to your questions, comments, feedback or inquiries
  - To plan and host events, webinars, or online forums in which you can participate, including with partner organizations
  - To send you newsletters or information about BCA
  - To subscribe or unsubscribe you to one of our mailing lists, upon your request
  - To communicate with you about BCA, our members, partners and affiliates
  - To enhance your browsing experience by personalizing the website
  - To engage in online advertising

#### 4. INFORMATION SHARING POLICIES

- 4.1 **Limitation on Sharing Personal Information**: BCA will not sell, rent or otherwise share your Personal Information with any party except as outlined in this Privacy Statement.
- 4.2 **Members and Other Third Parties**: BCA may share non-personal, anonymous and aggregate data with its membership, partners, advertisers and affiliates.
- 4.3 **Successors:** If in the event of a sale, merger, change in control or transfer of substantial assets, reorganization or liquidation, we may transfer, sell or assign to third-parties information about your relationship with us. This information might include Personal Information that you provide.
- 4.4 **Legal or Government Requests:** We may share your Personal Information if permitted or required by law or to comply with a legal process.

#### 5. SECURITY OF YOUR INFORMATION

5.1 Protecting the security of your Personal Information is of utmost importance to us. BCA uses reasonable security safeguards to protect the Personal Information we collect from unauthorized access, use, disclosure, alteration and destruction, such as including a Secure Socket Layer (SSL) certificate to encrypt your Personal Information while transmitting over
